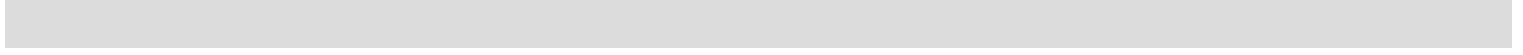


Policy DM12 of the Local Development Plan requires that where there is a deficiency of outdoor open space and play facilities, provision will be sought from new residential development of 10 or more units based on a minimum of 2.4 ha per 1,000 projected population. The 2.4 ha standard is broken down as follows:
